## What is Chestnut Tree House?

Chestnut Tree House is the children's hospice for East and West Sussex and South East Hampshire, and cares for children and young people with life-shortening illnesses and their families.

At Chestnut Tree House our goal is to provide the best quality of life for children, young people and their families, and to offer a total package of practical, social and spiritual support throughout each child's life, however short it may be.

For every life-limited child that Chestnut Tree House is caring for, there is another local child who we are not yet reaching due to lack of funding.

It costs well over £3.5 million each year to provide all our care services, both at the hospice and in families' own homes across Sussex and South East Hampshire. Families are never charged for their care and the hospice receives less than 7% from central government, so it relies heavily on the generosity, help and support of the local community. We hope you will consider helping us via Payroll Giving.

## What is Payroll Giving?

It is a simple, tax-free way of giving to charity direct from your pay.

## How does it work?

If you donate £5 a month, it will only cost you £4 – that's because the tax man pays the rest! Payroll Giving donations cost even less for higher rate tax payers.
