



Your Chestnut Tree House charity entry for the Adrenaline Package which includes the bungee jump, wing walk and 15,000ft sky dive in 2021 is conditional on agreement with all the points below:

Chestnut Tree House Bungee Jump 5 June 2021

Your Chestnut Tree House charity entry in the June 2021 bungee jump is conditional on agreement with all the points below:

1. To pay at least 50% of the minimum sponsorship (£125) to the charity at least two weeks before the date of the challenge (22 May 2021) with the remaining monies before the 5 July 2021.
2. If you do not take part in the event, your registration fee and any sponsorship money raised will be treated as donations unless your sponsors contact Chestnut Tree House directly for a refund.
3. If you cancel your place, you understand that the registration fee is non-refundable and non-transferable
4. You agree to raise all money using legal methods and complying with the advice given in the fundraising pack.
5. You understand that Gift Aid is not included in your minimum sponsorship, but that money raised from Gift Aid is a valuable bonus for Chestnut Tree House.
6. You give Chestnut Tree House permission to use any photographs / videos taken of you at this event. If you would prefer not to be photographed please inform a member of staff on the day of the event.
7. If you are unable to participate in the event, you agree to cover the cost of your place by donating £100 (inclusive of your registration fee) to Chestnut Tree House.
8. You accept full responsibility and acknowledgment that you are aware of the weight limit for this event (120 KG / 18.9 stone for a solo jumper) and you are within this limit.
9. You accept full responsibility and acknowledgment that if any of the following apply, you must seek professional medical advice before jumping and sign a non-standard waiver;

- Aged 50 years or above
- High blood pressure
- Heart condition
- Suffer from dizziness or epilepsy
- Damage to neck, back, spinal column, legs or eyes
- Asthma
- Medication – if you are taking any form of prescribed medication, please inform us of how this may affect you

10. You are over the age of 14 and you acknowledge that if you are 14 or 15 years old a parental signature will be needed on the day of the jump.

11. You understand that you will need to read a health warning notice and sign a waiver on the day of the jump.

Chestnut Tree House Wing Walk Terms of Acceptance and The Wing Walk Company Waiver 18 July 2021

Your charity wing walk is conditional and dependent on the following Chestnut Tree House T&Cs and Wing Walk Company waiver.

12. You agree to raise all sponsorship using legal methods and comply with the advice given in the Fundraising Pack and Fundraising Hub*

13. You agree to raise at least £500 of the minimum sponsorship one month prior to your wing walk day (this is to cover the actual cost of your wing walk)

14. All sponsorship should be collected and paid to Chestnut Tree House no later than 1 month after the event

15. You understand that Gift Aid is not included in the minimum sponsorship, but that monies raised from Gift Aid are a valuable bonus for Chestnut Tree House

16. You give Chestnut Tree House permission to use any photos / videos taken of you at the event, to raise awareness and / or money for Chestnut Tree House's work

17. If you do not take part in the event / cancel your place, any sponsorship raised will be treated as a donation. Any of your sponsors wanting a refund must contact Chestnut Tree House directly

18. If you are unable to participate in the event, you will contact the Events Team to discuss your options: Where possible, the Events Team will endeavour to find you an alternative date to complete your challenge. You may also be able to look at an alternative challenge too. If you wish to fully cancel your challenge, you agree to cover the cost of your wing walk place by donating £390 to Chestnut Tree House**

19. You have read, understood, and agree to The Wing Walk Company's guidelines around wing walkers age limits, weight restrictions and medical conditions***

*If you are unsure about the legalities or requirements of particular fundraising, please do get in touch with the Events Team who will be able to offer further guidance.

**Your registration and any sponsorship already raised can be used for this.

***The Wing Walk Company are the third party who deliver the wing walk on behalf of Chestnut Tree House. Chestnut Tree House cannot be held responsible if you do not meet the third parties T&Cs on age limit, weight restriction, or medical conditions at the time of your wing walk.

The Wing Walk Company Waiver

A reminder that the Wing Walker must adhere to the following guidelines:

The Wing Walker must be aged between 18 - 80 years of age at the time of the wing walk.

The maximum weight is 85kgs (13st 4lb). On the day of your flight, if you arrive and you are overweight, you will not be able to fly and there will be a £200 re-booking fee.

The Wing Walker will be required to sign a declaration of fitness at the briefing. If the Wing Walker suffers from high blood pressure, epilepsy, fainting, blackouts / dizziness, heart or lung disease you cannot participate. If your medical condition is being managed; you may be able to participate and should discuss this with your GP / Consultant and provide proof of this before you fly.

If the Wing Walker suffers from drug or alcohol addiction, mental health issues, or are pregnant they will not be able to participate.

Chestnut Tree House Charity 15,000ft tandem Skydive 15 August 2021 Terms of Acceptance

20. You agree to raise at least 80% of your minimum sponsorship two weeks before your jump (this is when Chestnut Tree will be invoiced for your jump). Remaining sponsorship money should be collected and paid to Chestnut Tree House no later than 1 month after the event.

21. If you cancel your dive*, any sponsorship money raised will be treated as donations unless your sponsors contact Chestnut Tree House directly for a refund.

22. If you cancel your dive*, you agree to cover the cost of your dive by donating £235 to Chestnut Tree House – any sponsorship raised will be counted against this total.

23. You agree to raise all sponsorship money using legal methods and complying with the advice given in the Fundraising Pack.

24. You understand that Gift Aid is not included in the minimum sponsorship, but that money raised from Gift Aid is a valuable bonus for Chestnut Tree House.

25. You give Chestnut Tree House permission to use any photographs / videos taken of you at this event, to raise awareness and / or money for Chestnut's work. If you pay for a photo / video package directly through Go Skydive, Chestnut Tree would appreciate being able to use this footage for future marketing and raising awareness – Chestnut Tree House will contact you separately on this.

*this is for a full cancellation of your jump by your choice, not a rescheduling of your jump.
